## 2018 HOA ANNUAL MEETING & ELECTIONS MINUTES

- 1. Meeting called to order by the President of the Board at 6 PM
- 2. Confirmed roster of homeowners present. No proxies were offered.
- 3. Confirmed proof of notice of meeting or waiver of notice.
- **4.** Jay Hallowell read minutes of prior meeting.
- 5. Reports of officers:
  - **a.** Jay Hallowell reported on HOA maintenance. HOA will continue with current contractors.
  - **b.** Derald Reisinger reported on HOA finances.
  - **c.** Danna Krill reported on resolution of items discussed at last homeowners meeting. Also discussed need for Special Projects volunteers.
- 6. Reports of committees:
  - **a.** Neighborhood Watch: Willie Hardin provided an updated HOA roster.
  - **b.** Architectural Review:
    - i. Chuck Inks provided update and reiterated requirements.
    - ii. Chuck and Dennis Carney completed their one-year voluntary service.
    - iii. Coy Krill volunteered to serve one year. Two additional volunteers are needed.
- 7. Election of two (2) Directors
  - **a.** Derald retired from the two year position as Treasurer.
  - **b.** Jay fulfilled the two year position as Secretary
  - c. Danna nominated Jay Hallowell to serve again. Norm Moss seconded the motion.
  - d. Norm nominated Willie Hardin. Chuck Inks seconded motion.
  - e. Vote for Directors by the HOA, counted by Norm Moss and Derald Reisinger.
  - f. Both nominees voted in by HOA as new Board members.
- 8. Unfinished Business
  - **a.** Danna provided an update on Red Diamond Construction/Hayden Homes.
  - **b.** Danna provided the response letter from Red Diamond's commercial insurance company, Alaska National, and discussed.

    - ii. 11 votes No for litigation; 1 vote Yes for litigation

iii. The majority of homeowners vote to dismiss litigation, 11:1.

The Board members discussed recusing themselves from the vote, which resulted in a quorum not being present. Homeowners elected to revisit this topic at a later date.
